




Export Policies and Conditions of Sale

1. **Supply contract:** For all orders and deliveries our conditions of sale apply. All orders are subject to a confirmation, for validity. We reserve the right to alter, cancel or modify any or all agreements undertakings or contracts in the event of strike, fire, accident, war, or any other causes beyond our control. Any purchase order that is submitted to us will be deemed to be an offer to purchase products and we reserve the right to decline any or all such offers at our sole discretion. In all cases customers will waive all claims for damage or delivery.
2. **Delivery time:** All deliveries for purchase orders will be confirmed and acknowledged together with the delivery time. If the delivery time is exceeded no claims from the customer to the manufacturer will be accepted. All orders will be shipped in the most economical way.
3. **Prices:** Deliveries will be invoiced at the current valid prices. All prices are in EURO, if there is no other written agreement. Deliveries ex works, Deizisau Germany.
4. **Shipment:** All orders will be shipped from the DRÄCO-plant in Deizisau. DRÄCO may choose any carrier for all deliveries. Every effort will be made to ship orders complete; however, a product may not be available from time to time. In such instances we will advise the available date.
5. **Packing fee:** Special export packing, boxing or marking other than our standard packaging, is subject to an extra charge. Units ex. factory include packing, excluding overseas-packing. Spare parts / accessories ex factory, excluding packing.
6. **Loss, damage or shortage:** Immediately, upon receipt of the merchandise report all claims for damage or shortage directly to DRÄCO, within 10 days after receipt of shipment. Any delay may void claim for loss.
7. **Payment terms:** Payment must be made by irrevocable letter of credit (LC) or cash in advance. All invoices are payable in EURO, only. All costs for Bank-Certification of Origin by Chamber of Commerce and Embassy or Consulate fees have to be paid by consignees.
8. **Letter of Credit information:** The requirements of a confirmed irrevocable letter of credit or cash in advance follow.
